Whatever Happened to Louis XVII?

<u>ABSTRACT</u>: - The heir of King of France was thought to have died in prison in 1789. In fact, he survived prison and was taken to Ireland whence he came to Saint John, New Brunswick.

In the French Revolution dated to September 21, 1789, Louis XVI and Marie Antoinette son Louis Charles XVII was put in Bastille Prison with his sister and a priest. It was thought heretofore that the boy King died in that prison. He did not. He was rescued by Irish Politician Sir Edmund Burke who knew Marie Antoinette, in fact wrote about her as the Bright Morning Star c.f. Revelation 2:22) and had access to the royal children. (The bastard child of Marie Antoinette with Louis XVI's brother was the implant who took over the prison cell in Bastille). Whereas Louis was rescued at Christmas 1789 (Nostradamus: He will come to go in the corner of the Luna =Quarter Moon at Christmas 1789, where he will be taken to a strange land (Ireland). Burke put the boy King with his niece Mary Burke who subsequently married Patrick Ce....gh in Cork. They migrated north to Tipperary where they settled in Toomvera, just East of Neenah. Louis was given an adopted name of Thomas, then John. His adoptive family had 7 children (James, John, Thomas, Patrick, William, Michael, Catherine and Mary). They all came to North America except Michael who stayed in Ireland. Thomas was educated as a school teacher like his adoptive brother James. Thomas taught school in Silvermines, Tipperary in 1808 before he married Irish royalty, Margaret O'Brien at Limerick at St Mary's Cathedral. They had 10 kids, who all together migrated to Canada in 1833. They sailed under the alias "Ryan" except for 3 children who used Ce.....h. There is a Catherine relative on-board the same ship. This is found in the Ships Records for the Ward-Morning Star in the Port ships list. Upon arrival, Thomas purchased 100 acres in Kings

County in what became known as Ryan Settlement. There were no runs in the area according to Ruby Cusack, genealogist. Thomas applied for a Teachers Petition shortly after his arrival in Canada. About half of Thomas' children migrated to the State of Massachusetts, United States of America. His eldest son, was John of Maine who had children who had no heirs. When Margaret (O'Brien) died, (tombstone found by a local genealogist), Thomas remarried under the name John Collins to widower Catherine Smith. Vincent Smith had a house as a shipbuilder on High Street and Albert Pierce had a harness Shop nearby on Simond Street. Thomas died in 1873, after faking his death in the epidemic of cholera in 1854. He had 4 boys (Thomas, John, Charles and Louis) and a girl Mary. This was a protestant marriage however and therefore does not meet Salic law. Thomas's heirs are John (the John d1904; George; John Joseph; George Aloysius (Louis); King Andrew Michael; and Dauphin Luke; Donald Thomas; etc. The family in question was tested for YDNA. It was found that they are RL21-L226 further R-DC127 that is presently known as Irish Type III, the Irish Royal Dalcassians. However, the royal throne of Ireland (the O'Briens) come from Mileisus, and the French Throne comes from Marchir of Narbonne (725-765 BC Common Ancestor of the Dalcassians). They were both of the Royal House of Israel. There is the rare marker DYS391=12 rare among Dalcassians. Only three tested so far have it? It indicates the families strain is older that Cormac CAS.

The RL226 is the royal Jewish Line fvrom Machir of Narbvonne. It went from Israel to the British Isles
